Direct Debit Request Service Agreement 1. Direct Debit is not available on the full range of accounts. If in doubt, please refer to your financial institution to confirm that your nominated account can accept direct debits. 2. You are advised to check your account details by contacting your financial institution. 3. Please ensure sufficient clear funds are in the nominated account when payments are to be drawn, as Red Cross will not be responsible for any overdrawn fees or interest charges. 4. Should you wish to modify or cancel the Direct Debit agreement please telephone 1800 811 700 within 14 days of the next debit. 5. Please include your name and address in all communications addressed to Red Cross. 6. Should you have any queries or dispute the debit item, please contact Red Cross in the first instance, rather than your financial institution. This should be done at least 5 working days prior to the next scheduled drawing date. 7. Your records and account details will be kept private and confidential, except that information provided to our financial institution to initiate the drawing from your nominated account. 8. Your personal details will be disclosed only if agreed to by yourself or to a financial institution if a claim is made for an alleged or wrongful debit. 9. Red Cross will, as agreed to by you, debit your nominated account in order to contribute to the work of Red Cross. This transaction will take place on or around your chosen debit date and then every four weeks thereafter. Should this fall on a non-business day, we will debit your account the next business day.
