
**INTERESTED
PARTIES:**

Subject to the existence of a written contract or other relevant arrangement involving the Insured and the parties referred to below, the policy indemnifies such parties for their respective rights and interests as per the policy definition 4.10 (c), i.e. "any person, principal, organisation, trustee, estate or other entity for whom or for which the Insured is obligated: (i) by written contract to provide insurance coverage as an additional insured or an insured or otherwise, such as is afforded by this Policy; (ii) to provide such insurance by reason of law, agreement or permit, but only to the extent required by such law, agreement or permit".
